SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal

fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found $\underline{\mathsf{HERE}}$.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. • ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such

notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

• ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the

plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. On a weekly basis, our Pupil Services Team meets to discuss individual student progress. We use a range of progress monitoring tools (examples laited above) to monitor these. We have expanded student access to ELA and Math intervention services by increasing the number of service providers we house in buildings.

The District is ai% high needs, low wealth district.i% Over 80% of our student poulatini% fall into a category listed in the prompt above.i% The majority of our students currently qualify for free and reduced lunch, a dispropriate number of our students are transient throughout the school year and we continue to provide supports to numerous students with disabilities as well as students who are homeless (or unaccompanied youth.)

Using a wide range of data points and accessing our weekly grade level meetings with advanced level pupil study teams, we review all students who have data reports (inclusive of behavioral; academic; social emotional; attendance; etc.) and target three to six weeks based intervention plans for each student regardless of their identification/subgrouping.i¾ This methodology has improved student attendance, developed our response plans to support students, and ultimately stregthen our student's academic success inclusive of graduation rates pre-pandemic.i¾ We will continue to use this model and further improve upon it to monitor our students.i¾ i¾ We emphasize that data comes in many ways, we consider both qualatative as well as quantitative data in our analysis and it is rare that students have similar data profiles due to the scope of review that we conduct.i¾ This model is also used to monitor our Rtl practices and student identification process for special education resources.i¾ i¾

It is through the intentional efforts by ELA and Math interventionists and special educators, we have targeted progress monitoring tools and professional development to skill areas that students must demonstrate. Upon the discovery of deficets, interventioniists will be addressing in 1:1 or small group programming.
