






Proposition 1:

School Budget for 2022-2023

“ Shall the Board of Education purchase and, at the option of the Board, finance three (3) school buses estimated cost not to exceed \$350,000, including necessary furnishings, fixtures and equipment and all other necessary costs incidental thereto and to expend a total sum not to exceed \$350,000 which is estimated to be the total maximum cost thereof, and levy a tax which is hereby voted for the foregoing in the amount of \$350,000, which shall be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education and in anticipation of the collection of such tax, bonds, notes or installment purchase contracts are hereby authorized to be issued or executed at one time, or from time to time, in the principal amount not to exceed \$350,000 and a tax is hereby voted to pay the interest on said obligations when due? ”

Proposition 2:

Purchase Student Transportation Vehicles



“ To elect a total of two (2) members to the Board of Education for three year terms commencing July 1, 2022 and expiring on June 30, 2025. ”

ONE RESIDENT (JESSICA WAKEFIELD) HAS SUBMITTED A PETITION FOR ONE OF THE TWO OPEN SEATS. VOTERS MAY VOTE FOR UP TO TWO CANDIDATES; EITHER MRS. WAKEFIELD, PER THE BALLOT OPTION, AND A WRITE-IN CANDIDATE, OR BY WRITING IN UP TO TWO OTHER CANDIDATES.

INSTRUCTIONS FOR VOTING:

1. Mark only with a writing instrument provided by the election inspectors.
2. To vote for a candidate whose name is printed on this ballot, fill in the oval (●) completely by the name of the candidate.
3. To vote for a person whose name is not printed on this ballot, write or stamp his or her name in the space labeled "write-in" that appears at the bottom of any candidate's name, and fill in the oval (●) completely corresponding with the write-in space in which you have written a name.
4. Any other mark or writing, or any erasure made on this ballot outside the voting squares or blank spaces provided for voting, will void this entire ballot.
5. Do not overvote. If you select a greater number of candidates than vacancies to be filled, your ballot will be void for that candidate.
6. If you tear, deface or wrongly mark this ballot, return it and obtain another. Do not attempt to correct mistakes on the ballot by making erasures or cross outs. Erasures or cross outs may invalidate all or part of your ballot. Prior to submitting your ballot, if you make a mistake in completing the ballot or wish to change your ballot choices, you may obtain and complete a new ballot. You have a right to a replacement ballot upon return of the original ballot.
7. After completing your ballot, insert it into the ballot scanner and wait for the notice that your ballot has been successfully scanned. If no such notice appears, seek the assistance of an election inspector.

- Be a citizen of the United States
- Be at least 18 years of age
- Be a resident of the District for a period of at least 30 days prior to the day of the vote
- Not be disqualified by any reason set forth in NYS Election Law §5-106.

VOTING INFORMATION Q&A

When and where is the budget vote?

The annual School District Board of Education Election and Budget Vote will take place from 9 a.m. to 7 p.m. on Tuesday, May 17, 2022, at the Hannibal High School. Please park in the district office parking lot and follow the signage on the entry door for voting location.

How do I vote?

Votes may be cast either in-person on May 17 or via an absentee ballot. It is advised that voters request an absentee ballot (if not voting in-person) no later than May 9. To ensure timely delivery and receipt, please mail your completed absentee ballot to the district clerk by May 12, or hand-deliver it to the district clerk by 5 p.m. May 17.
